

INTERDISTRICT ATTENDANCE

The Culver City Unified School District recognizes that families attending with an interdistrict attendance permit further contribute to the rich diversity of our student body.

The Governing Board recognizes that parents/guardians of students who reside within the geographic boundaries of one district may, for a variety of reasons, desire to enroll their children in a school in another district. It is the intent of the Governing Board to accept students who live outside of the Culver City Unified School District boundaries (non-resident students) and release students who live within the CCUSD boundaries (resident students) on interdistrict attendance permits under Education Code 46600-46611. The Board desires to communicate with parents/guardians and students regarding the educational programs and services that are available.

Acceptance of non-resident students will be maintained at a level that assures enrollment of resident students will be given priority in their neighborhood schools, allows for adequate scheduling flexibility at the middle and high schools, and will not place the District at risk of violating local class size agreements set in the District's collective bargaining agreement, the District's limits pursuant to the State K-3 Grade Span Adjustment, maximums established by the State of California or exceeding the physical capacity of the site or classroom pursuant to the District's facilities master plan or other facility planning document.

The Superintendent or designee is hereby directed to leave sufficient room in each class, grade level, program, and school building for new Culver City residents who may move into the District over the summer or enroll during the school year.

Upon receiving an incoming interdistrict attendance permit application for transfer into the district that has been approved by the student's district of residence, or upon receiving an outgoing interdistrict attendance permit application from the parent/guardian of a district student who wishes to enroll in another district, the Superintendent or designee shall review the request and may approve or deny the permit subject to the terms and conditions referenced in AR 5117.

The Superintendent or designee shall ensure that interdistrict attendance permits specify the terms and conditions for the granting, denial, or revocation of the permit. Once an interdistrict attendance permit has been granted and a student has enrolled, a student is not required to reapply unless an interdistrict attendance agreement between the governing boards of the district of residence and the district of enrollment states otherwise.

The parent/guardian is responsible for providing transportation to and from school and making sure the student maintains satisfactory attendance/reports to class on time. For safety reasons, students cannot be brought to school excessively early or left excessively late.

Students enrolled on a valid interdistrict attendance permit shall be allowed to continue in the District until they leave or graduate, unless revoked for reasons delineated in AR 5117. Students enrolled on a valid interdistrict attendance permit are expected to uphold appropriate behavior

standards, maintain satisfactory attendance, and make appropriate academic efforts, consistent with the expectations of all CCUSD students. Students entering grades 11 and 12 shall not have their interdistrict attendance permits rescinded by either district. (Education Code 46600)

The Superintendent or designee may deny interdistrict attendance permits when at capacity limits as defined/determined by AR 5117.

The Board recognizes that the District may be capable of serving additional students. The Board may delegate to the Superintendent or designee the authority to issue or accept interdistrict attendance permits in accordance with procedures referenced in AR 5117. It is the policy of the District that each interdistrict attendance permit application be evaluated on its own merits.
