9.1a Approval is Recommended for the Suspended Expulsion of Pupil Services Case #06-11-12

Under AR 5144.1(s) the Board of Education may suspend enforcement of an expulsion.

The suspension of the enforcement of an expulsion shall be governed by the following:

- a) The Board may, as a condition of the suspension of enforcement, assign the student to a school, class or program appropriate for the student's rehabilitation.
- b) During the period when enforcement of the expulsion order is suspended, the student shall be on probationary status.
- c) The suspension of the enforcement of an expulsion order may be revoked by the Board of Education if the student commits any of the acts listed under "Grounds for Suspension and Expulsion."
- d) When the suspension of the enforcement of an expulsion order is revoked, a student may be expelled under the terms of the original expulsion order.

The Administrative Hearing Panel unanimously recommended: That Case #06-11-12, a 12th grade student at Culver City High School, be expelled from the Culver City Unified School District. That the student's expulsion be suspended, under the terms and conditions of a suspended expulsion that will remain in effect through the second semester of 2012. That Case #06-11-12 be assigned to Culver Park High School or be allowed to enroll in an alternative program within the district such as the Culver Park Independent Study Program or the Adult School at the age of 18.

RECOMMENDED MOTION: That the Board suspend the Expulsion of Case #06-11-12 until the second semester of 2012 and assign the pupil to Culver Park High School.
