Facts, Finances, & Timelines

BOND FACTS:

- A Prop 39 General Obligation (GO) Bond is a commonly used by California school districts to generate Capital Project funds.
- Repayment is made from taxes levied on the Assessed Value (AV) of properties within the district boundaries.
- Requires approval of the Board of Education through a Resolution containing:
 - The Bond Authorization Amount
 - The Project List
 - The Estimated Tax Rate
- A Prop 39 GO Bond Requires 55% Approval by the Registered Voters, and Must Include the Formation of a Citizen's Oversight Committee

CCUSD Bond Sub-Committee

Facts, Finances, & Timelines

The Current Average 2013-14 Tax Rate for Los Angeles County Unified School Districts with Bonds is \$83.18 per \$100,000 of Assessed Valuation.

CCUSD's Current 2013-14 Tax Rate is \$31.41 per \$100,000 of Assessed Valuation.

BOND FINANCES:

The Passage of a GO Bond with a Tax Rate of \$40 per \$100,000 of AV would provide \$69,000,000 in Facilities Funding for CCUSD Schools.

The Tax Payment for a GO Bond with a Tax Rate of \$40 per \$100,000 of AV Would be \$147.25 Per Year for the Average Culver City Homeowner (based on our average AV of \$386,135).
