Call to Order

Board President Dr. Russell called the meeting of the Culver City Unified School District Board of Education to order at 6:00 p.m. The Board adjourned to closed session at 6:01 p.m. and reconvened the public meeting at 7:05 p.m. with all Board members in attendance. Ms. Jan Glusac led the Pledge of Allegiance.

Report from Closed Session

Dr. Russell reported that the Governing Board met in Closed Session regarding issues listed on today's Closed Session agenda and announced that no reportable actions were taken.

8. Adoption of Agenda

It was moved by Dr. Beagles-Roos and seconded by Mr. Zeidman that the Board approve the agenda of January 29, 2008. The motion was unanimously approved.

9. Consent Agenda

Dr. Russell called the Consent Agenda and asked if any member of the audience or the Board wished to withdraw any item. Mr. Carlos Valverde requested that item 9.5 be withdrawn. Dr. Beagles-Roos requested that items 9.6, 9.7 and 9.9 be withdrawn. Dr. Russell stated that item 9.8 was being pulled from the agenda. It was moved by Mr. Zeidman and seconded by Mrs. Davis to approve Consent Agenda Items 9.1 - 9.4 and 9.10 as presented. The motion was unanimously approved.

9.5 <u>Approval is Recommended for Overnight Out-of-State CCHS Field Trip – Student Intercultural</u> Advisory Committee (SIAC), Retreat and Training, Zaca Lake, CA Feb. 21-23, 2008

Mr. Valverde pulled this item to speak in favor of the students taking the trip and to provide the Board with additional information regarding the trip. Student Menelik Tefari also spoke in favor of the trip being approved. It was moved by Mr. Zeidman and seconded by Dr. Beagles-Roos that the Board approve the proposed overnight field trip for 45 students to be accompanied by teachers Rebekah Howard, Jose Montero and Carlos Valverde to Zaca Lake, CA, February 21-23, 2008 as presented. The motion was unanimously approved.

9.6 Approval is Recommended for Textbook Adoption, CCHS Science and Social Studies

Dr. Beagles-Roos pulled this item to correct the title of the book to include the word "Chemistry." It was moved by Dr. Beagles-Roos and seconded by Mrs. Davis to approve the Culver City High School's request for the new Science and Social Studies textbooks, *Essentials of Human Anatomy & Physiology, Prentice Hall Biology*,

Prentice Hall Earth Science, Holt Physics, Chemistry, Matter and Change, and World Geography as corrected. The motion was unanimously approved.

9.7 <u>Approval is Recommended for Inter-District Attendance Agreement between the South Pasadena</u> Unified School District and the Culver City Unified School District

Dr. Beagles-Roos pulled this item to request additional information. Dr. Fiello responded. It was moved by Dr. Beagles-Roos and seconded by Mrs. Davis to approve the Interdistrict Attendance Agreement between the South Pasadena Unified School District and the Culver City Unified School District as presented. The motion was unanimously approved.

9.9 Approval is Recommended for the Arts and Music Block Grant Resolution

Dr. Beagles-Roos pulled this item to inquire as to the operational cost. Dr. Fiello provided additional information. It was moved by Dr. Beagles-Roos and seconded by Mr. Zeidman to approve the Resolution to authorize the Culver City Unified School District's 2007-2008 Arts and Music Block Grant as presented. The motion was unanimously approved.

10.1 American Citizenship Awards

Dr. Fiello read the names of each school's recipients of the American Citizenship Award for the month of January. The recipients were Timofe Okuboyejo from El Rincon Elementary; Alexis Flores from La Ballona School; Uju Izchukwu from Farragut School; Elliot Stanger from El Marino School, and Pearl Thompson the December recipient; Kiarra Mueller from Linwood Howe School; Redmond Stephan from Culver City Middle School; Cesar Noriega from Culver Park High School; and Marlen De Silva from Culver City High School. Dr. Russell presented each recipient with a pin and thanked them and their families for attending the meeting. Dr. Russell also extended commendations to former Board Member, Marla Wolkowitz, for starting such a great tradition of handing out the awards.

10.2 Spotlight on Education - Farragut Elementary School

Dr. Fiello introduced Mrs. Barbara Brown, Principal at Farragut Elementary. Mrs. Brown presented information to the Board on Farragut's after school program called Farragut's After School Arts School & Technology (F.A.A.S.T.). Mrs. Wacker also presented information on the program. One of the students, Jamison, gave a guitar performance.

Board members thanked Mrs. Brown, commended the student on his performance, and commented that the program was great.

The motion was unanimously approved.

14.2 <u>Approval is Recommended for Change in Job Title from Instructional Aide IV to Instructional</u> Assistant – Adult School and for New Classified Job Description

It was moved by Dr. Beagles-Roos and seconded by Mrs. Davis that the Board approve the new position title, changing it from Instructional Aide IV to Instructional Assistant – Adult School, with the salary to remain at range 17 of the classified salary schedule, effective January 30, 2008, and the new job description as presented. The motion was unanimously approved.

14.3 <u>Approval is Recommended for Change in Job Title from Instructional Aide III to Instructional Assistant – Bilingual and for New Classified Job Description</u>

It was moved by Dr. Beagles-Roos and seconded by Mrs. Davis that the Board approve the new position title, changing it from Instructional Aide III to Instructional Assistant – Bilingual, with the salary to remain at range 16 of the classified salary schedule, effective January 30, 2008, and the new job description as presented. The motion was unanimously approved.

14.4 <u>Approval is Recommended for Change in Job Title from Teacher Aide to Instructional Assistant – Child Development and for New Classified Job Description</u>

It was moved by Dr. Beagles-Roos and seconded by Mrs. Davis that the Board approve the new position title, changing it from Teacher Aide to Instructional Assistant – Child Development, with the salary to remain at range 11 of the classified salary schedule, effective January 30, 2008, and the new job description as presented. The motion was unanimously approved.

14.5 <u>Approval is Recommended for Change in Job Title from Teacher Aide/Bilingual to Instructional Assistant – Child Development/Bilingual and for New Classified Job Description</u>

It was moved by Dr. Beagles-Roos and seconded by Mrs. Davis that the Board approve the new position title, changing it from Teacher Aide/Bilingual to Instructional Assistant – Child Development/Bilingual, with the salary to remain at range 11 of the classified salary schedule, effective January 30, 2008, and the new job description as presented. The motion was unanimously approved.

14.6 Approval is Recommended for Change in Job Title from Teacher Aide II to Instructional Assistant - Child Development II and for New Classified Job Description

It was moved by Dr. Beagles-Roos and seconded by Mrs. Davis that the Board approve the new position title, changing it from Teacher Aide II to Instructional Assistant – Child Development II, with the salary to remain at range 13 of the classified salary schedule, effective January 30, 2008, and the new job description as presented. The motion was unanimously approved.

14.7 <u>Approval is Recommended for Change in Job Title from Instructional Aide III/Technology Center Aide to Instructional Assistant – Computer Lab and for New Classified Job Description</u>

It was moved by Dr. Beagles-Roos and seconded by Mrs. Davis that the Board approve the new position title, changing it from Teacher Aide III/Technology Center Aide to Instructional Assistant – Computer Lab, with the salary to remain at range 16 of the classified salary schedule, effective January 30, 2008, and the new job description as presented. The motion was unanimously approved.

14.8 <u>Approval is Recommended for Change in Job Title from Physical Education Assistant to</u> Instructional Assistant – Physical Education and for New Classified Job Description

Dr. Beagles-Roos had concerns regarding the P.E. Assistants and who they would report to. She suggested an amendment to the motion to state "under the direction of an assigned supervisor". It was moved Mr. Zeidman to approve the new position title, changing it from Physical Education Assistant to Instructional Assistant – Physical Education, with the salary to remain at range 15 of the classified salary schedule, effective January 30, 2008, and the new job description as amended. The motion was unanimously approved.

14.9 <u>Approval is Recommended for Change in Job Title from Instructional Aide II to Instructional</u> Assistant – Special Education and for New Classified Job Description

It was moved by Dr. Beagles-Roos and seconded by Mrs. Davis that the Board approve the new position title, changing it from Instructional Aide to Instructional Assistant – Special Education, with the salary to remain at range 14 of the classified salary schedule, effective January 30, 2008, and the new job description as presented. The motion was unanimously approved.

14.10 <u>Approval is Recommended for Change in Job Title from Instructional Aide IIA to Instructional Assistant – Special Education IIA and for New Classified Job Description</u>

It was moved by Dr. Beagles-Roos and seconded by Mrs. Davis that the Board approve the new position title, changing it from Instructional Aide IIA to Instructional Assistant – Special Education IIA, with the salary to remain at range 16 of the classified salary schedule, effective January 30, 2008, and the new job description as presented. The motion was unanimously approved.

14.11 <u>Approval is Recommended for Change in Job Title and Salary Range from Teacher Aide</u> <u>III/Technology Center/High School (Salary Range 20) to School Technology Technician (Salary Range 21) and for New Classified Job Description</u>

It was moved by Dr. Beagles-Roos and seconded by Mrs. Davis that the Board approve the new position title, changing it from Teacher Aide III/Technology Center/High School (Salary Range 20) to School Technology Technician (Salary Range 21), effective September 1, 2007, and the new job description as presented. The motion was unanimously approved.
